Uniform Policy

We are very proud of our school and the high expectations we set ourselves. A visible sign of these high standards is our school uniform. We believe that wearing the Sherborne uniform:

- promotes pride in 'The Penny',
- engenders a sense of community and belonging towards the school and each other,
- identifies the children with our school and the Penny which, in turn, symbolises all the values and learning dispositions we stand for.

Our aim is to provide a clear uniform policy for pupils and parents and for staff to implement the policy firmly, consistently, and fairly at all times. Parents have a duty to send their children to school correctly dressed and ready for their daily schoolwork. One of the responsibilities of parents is to ensure their child has the correct uniform, and that it is clean and in good repair and we thank you for your support.

All pupils are expected to be in correct school uniform every day, and guidance is also given as to what is permitted during non-uniform days.

Please note our school uniform is in line with Circular No. (10) of 2024 from the Ministry of Education and Higher Education.

Alongside the uniform requirements it is expected that all pupils have a:

- water bottle with pupil's name
- Sherborne sun hat (Prep pupils) No hat, No play.
- Sherborne school rucksack (Prep pupils)
- Equipment for school as required per phase Pencil case, pencil, pens, ruler, eraser, sharpener, colour pencils, calculator
- School approved Windows device- Year 1 onwards

GENERAL APPEARANCE

Sherborne Qatar School for Girls holds the following expectations of general appearance of pupils.

- a. Hair Pupils hair should be tidy and of natural colour. If hair is longer than shoulder length it should be tied back with a dark hair tie.
- b. Jewellery -Pupils may only wear one pair of stud earrings no rings, necklaces, bracelets, anklets or any other item of jewellery should be worn. A traditional wrist watch may be worn but smart watches are not permitted.
- c. Makeup and nail varnish Pupils should not be wearing makeup or nail varnish and will be asked to remove it.
- d. Year 12 pupils may wear light make up and nail varnish in neutral shades. Heavy makeup and bright nail varnish is not permitted and pupils will be asked to remove it.
- e. A plain black or Navy-blue hijab/shayla (for pupils who choose to cover)
- f. A plain, dark coloured abaya e.g. black/navy-blue. Bright colours and vivid patterns are not permitted (for pupils who choose to cover). Pupils are not permitted to wear their abaya indoors during the school day.
- g. Black leather or leather look school shoes only not trainers
- h. A minimum 5cm below knee length skirt with black/navy blue non-transparent tights (if a skirt is worn)
- i. All items of clothing must be loose fitting in respect to local cultural sensitivity.

- j. All items of clothing should be non-transparent and loose fitting
- k. A lanyard worn around the neck at all times (Senior pupils)

EYFS 1 - KS1 DAYWEAR



- Plain white shirt or blouse, tucked in, with a collar and either wrist or elbow length sleeves
- Plain navy-blue V-necked jumper or cardigan
- Tartan pinafore
- White socks
- Black leather or leather look school shoes (trainers are only permitted for PE)

KS2 DAYWEAR



- Plain white shirt or blouse, tucked in, with a collar and either wrist or elbow length sleeves, loose fitting
- Pupils who choose to cover must wear a long sleeve shirt or have the school branded cardigan, loose fitting
- School branded navy-blue V-necked jumper or cardigan (navy-blue hoodies are not permitted)
- Tartan skirt 5cm below the knee
- White socks (for those pupils who wish to cover - non-transparent black or navy-blue tights)
- Black leather or leather look school shoes (trainers are only permitted for PE)
- For those who wish to cover hijab/Shayla should be navy-blue or black in colour and should be worn around the neck at all times in case of evacuation. Abayas should be plain and in dark colours eg black or navy blue – They should not be brightly coloured or have vivid patterns. Pupils are not permitted to wear their abaya indoors during the school day.

KS3 - KS4 DAYWEAR



- Plain white shirt or blouse, tucked in, with a collar and wrist (full) length sleeves, loose fitting
- School branded navy-blue V-necked jumper or cardigan (navy-blue hoodies are not permitted), loose fitting
- Navy blue full length or knee-length skirt (5cm below knee) or navy blue tailored loose fitting school trousers (not leggings)
- Sherborne Blazer (optional)
- Sherborne school tie according to House (optional)
- White or black socks or non-transparent black or navy-blue tights
- Black leather or leather look school shoes

Hijab/Shayla should be navy-blue or black in colour and should be worn around the neck at all times in case of evacuation. Abayas should be plain and in dark colours eg black or navy blue – They should not be brightly coloured or have vivid patterns. Pupils are not permitted to wear their abaya indoors during the school day.

Lanyards must be worn at all times.

KS5 DAYWEAR


Year 12 pupils are expected to wear business dress as described below.

- Plain shirt with a collar of light pastel colours, to be tucked in at all times, loose fitting
- Plain, dark coloured suit skirt (must be below the knee by 5cm or full length) or suit trousers, loose fitting
- Plain, dark coloured suit jacket/blazer, loose fitting, matching colour to skirt/trousers to be worn at all times around school unless in the sixth form common room
- V-necked black or navy jumper (optional)
- Black socks/black or navy-blue tights
- Plain black leather or leather look shoes, closed toe with a heel no greater than 1 inch (2.5cm) sandals are not permitted and trainers are only allowed for PE.
- Year 12 pupils are permitted to wear light makeup, nail varnish in neutral colours and light jewellery. Heavy makeup, jewellery or bright nail varnish colours will not be permitted
- Hijab/Shayla should be navy-blue or black in colour and should be worn around the
 neck at all times in case of evacuation. Abayas should be plain and in dark colours eg
 black or navy blue They should not be brightly coloured or have vivid patterns. Pupils
 are not permitted to wear their abaya indoors during the school day.

Lanyards must be worn at all times

- Navy blue PE shirt with amber stripe,
- EYFS- Year 4 plain navy-blue shorts (knee length to be worn with white/black/navy blue non transparent tights),or navy blue school tracksuit, loose fitting
- Year 5-Year 12 navy blue school tracksuit, loose fitting
- Training shoes (preferably black, or white for when we do indoor activity) and white/black socks.
- School zip top is optional.

Please check with your daughter's House with her class teacher before purchasing the House shirt (or school tie).

NON-UNIFORM DAYS

Pupils can wear clothing of their own choice on non-uniform days which will usually be related to a theme or event taking place in school. Usual standards and expectations will apply on non-uniform days, and all clothing must follow Qatari laws, morals, and values and be in compliance with Circular No. (10) of 2024 from the Ministry of Education and Higher Education.

- Clothes must cover shoulders, chest, and abdomens, and skirts/dressers or shorts must be minimum knee length (5cm below the knee) and be loose fitting
- Pupils should wear shoes or trainers. High heels, flip flops and slippers are not permitted.
- Light makeup can be worn. Pupils wearing heavy makeup will be asked to remove it
- No offensive, rude or inappropriate language or logos on clothing or accessories

Pupils who are not dressed appropriately will be asked to change and isolated from lessons/breaks until suitable clothing is brought to school.

NON-COMPLIANCE

Where parents may have any difficulty sourcing the correct uniform items, we ask parents to communicate this with us, including an order number from the uniform supplier, Noble House. Form tutors and Heads of Year must be kept informed and updated of any issues regarding uniform via email or Class Dojo, in order for us to support you and your daughter.

If you have any questions regarding what is acceptable and what is not permitted, please email your daughter's Head of Year or Deputy Head for any further clarification or guidance before purchasing the item.

Sanctions will be applied to pupils who are not in correct uniform or repeatedly do not have the correct equipment needed for school and are therefore, non-compliant with the uniform policy as well as the home-school agreement.
